The responses from employers are collected on the six point scale.

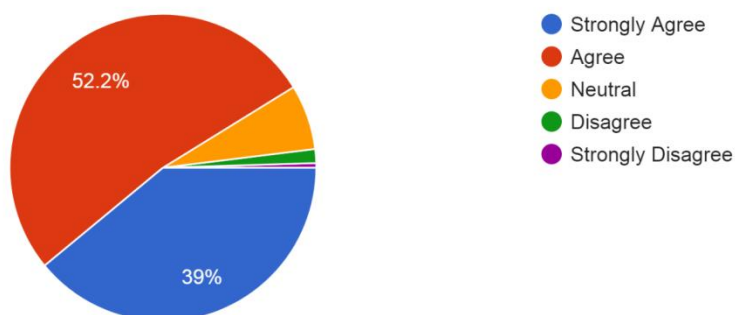

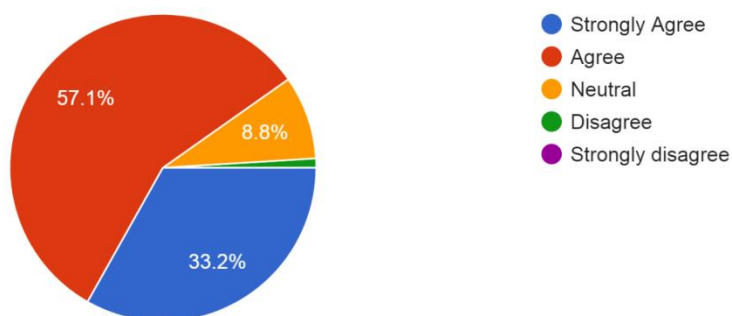

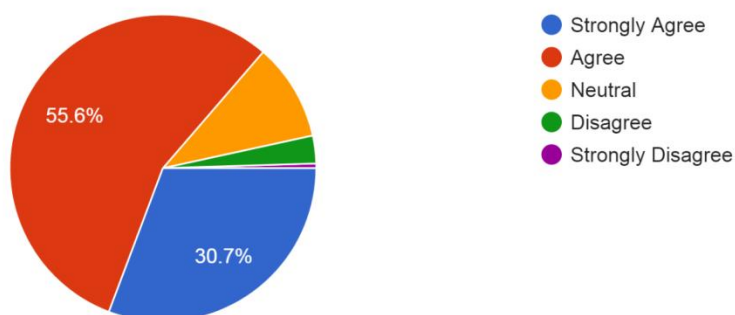

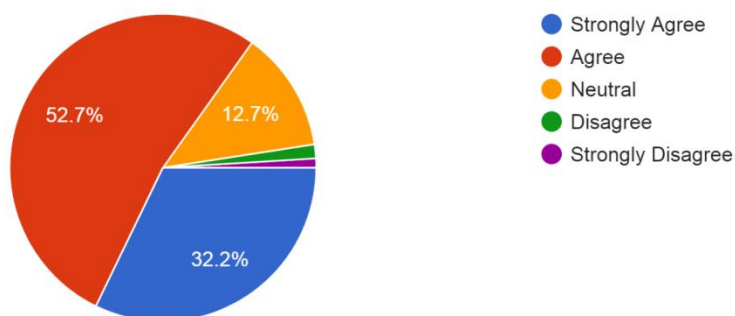

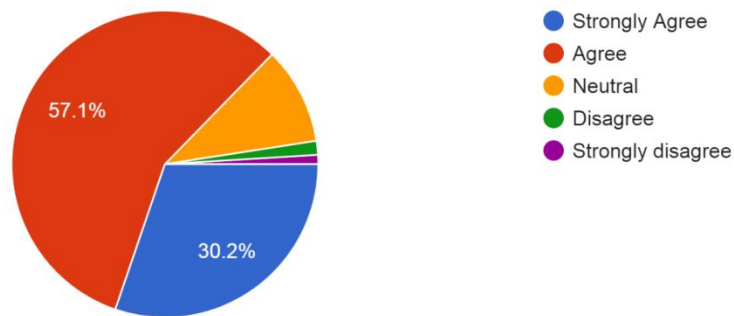

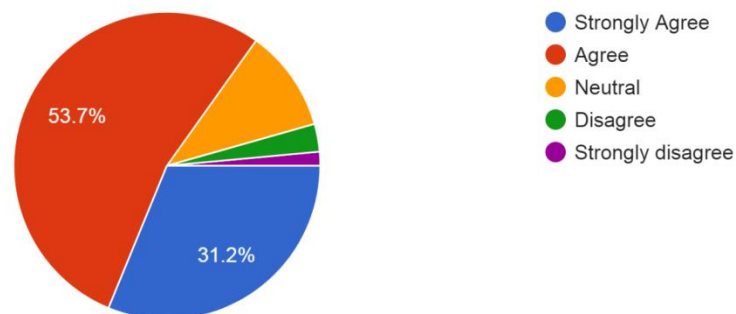

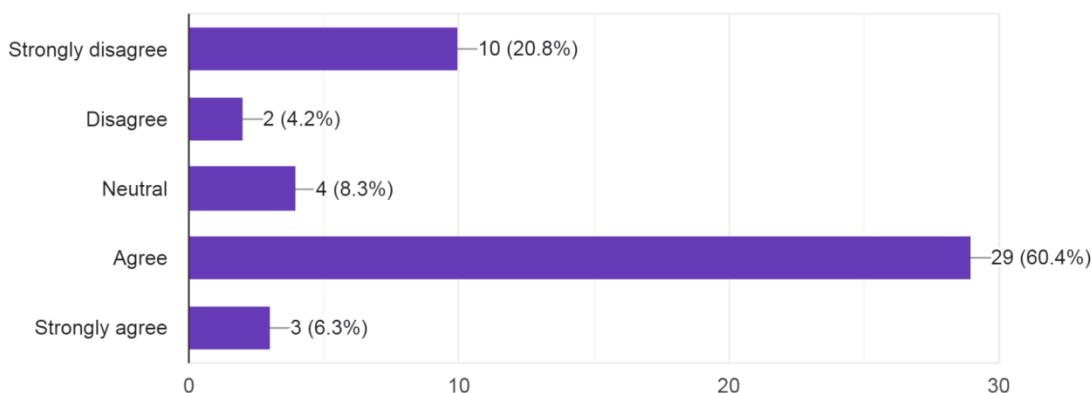

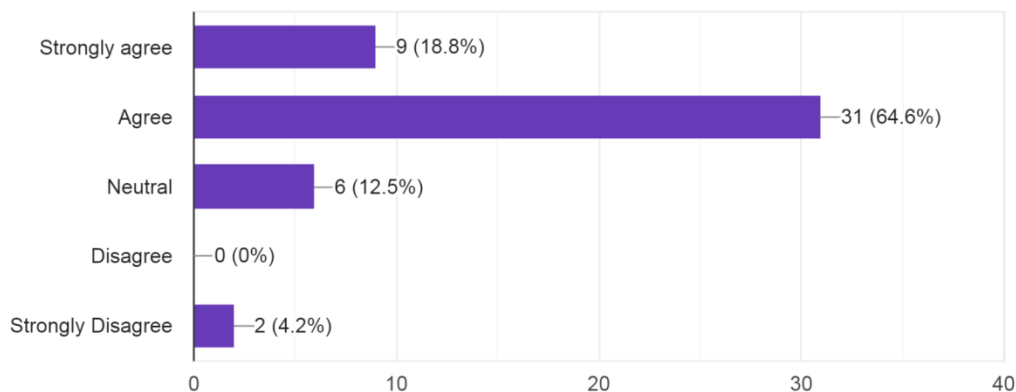

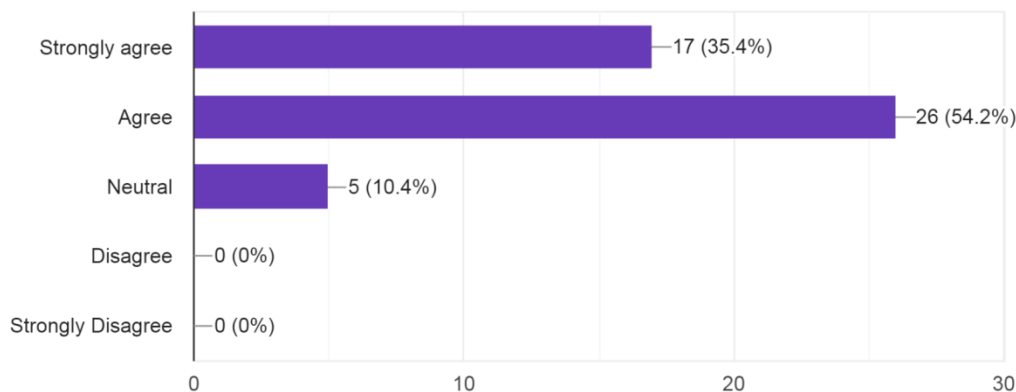

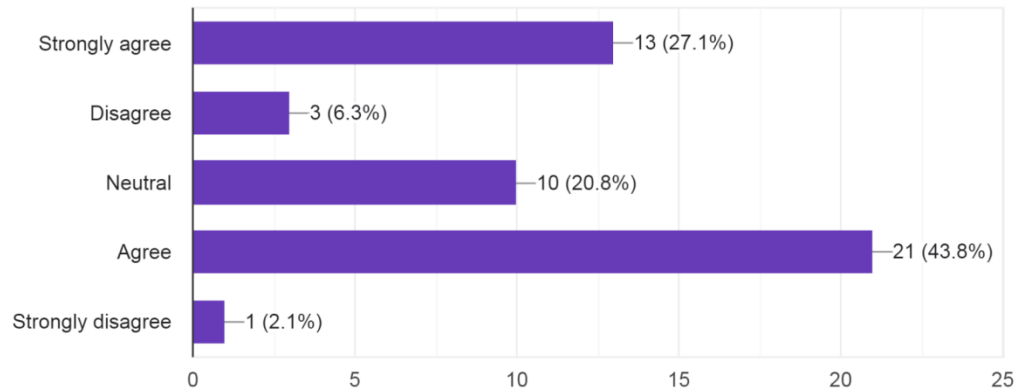

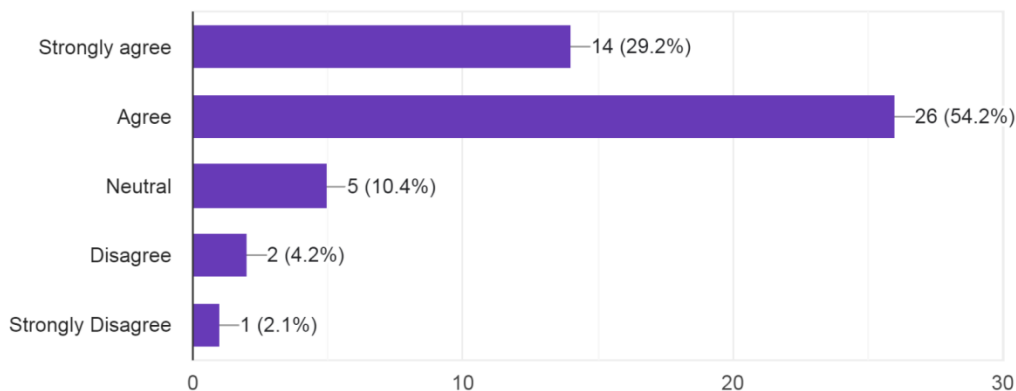

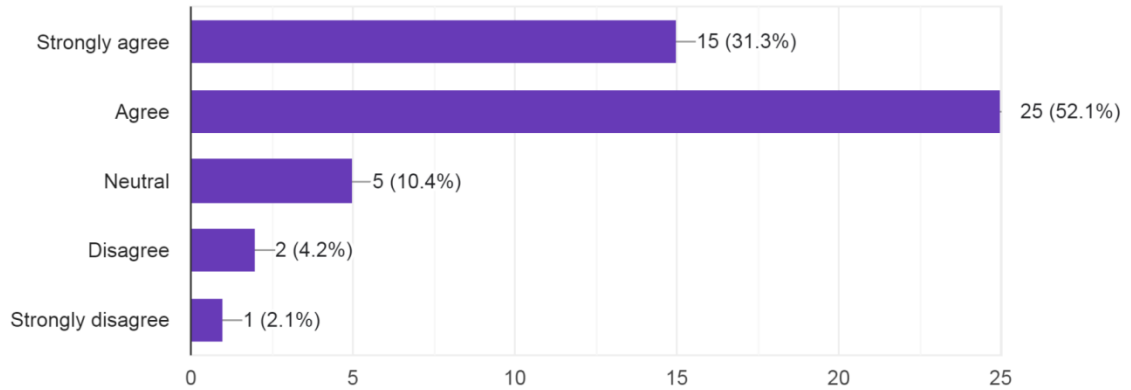

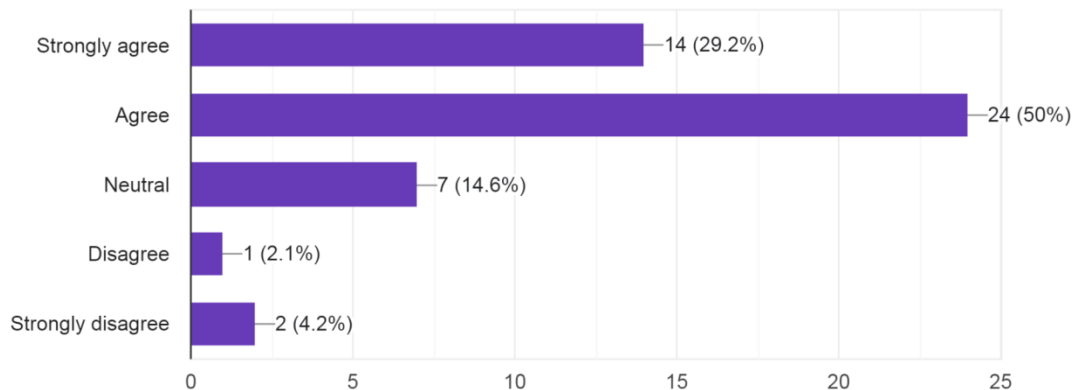

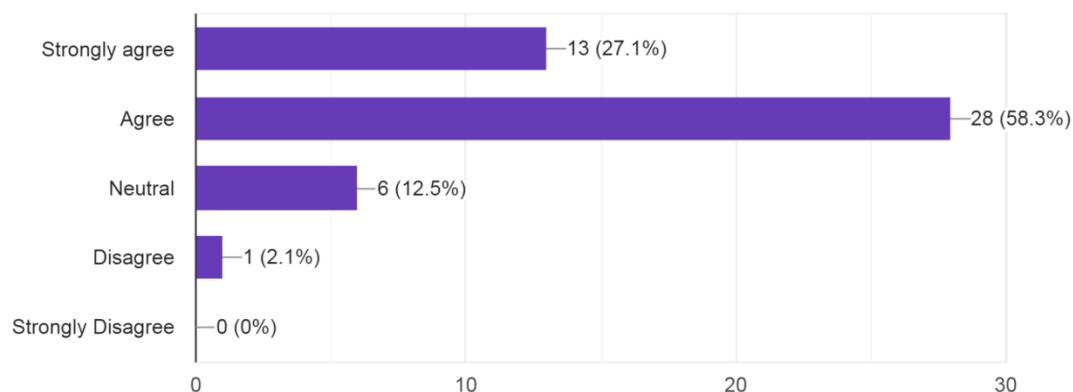

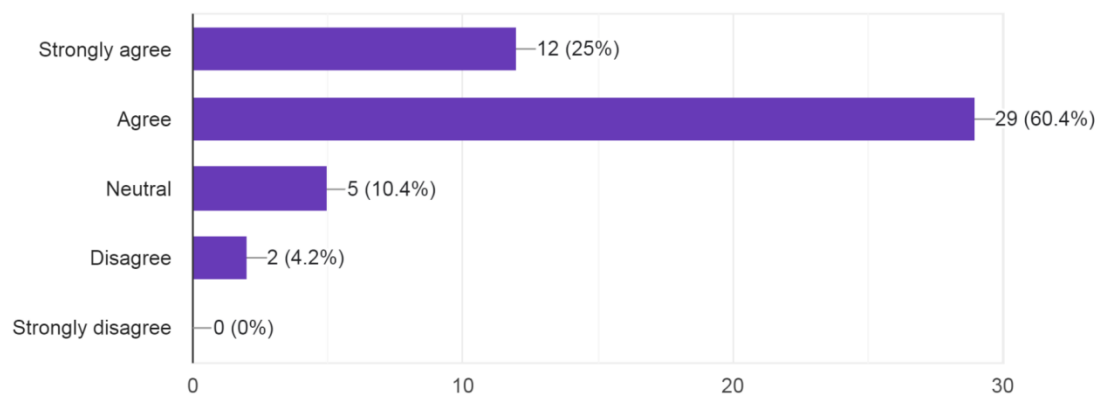

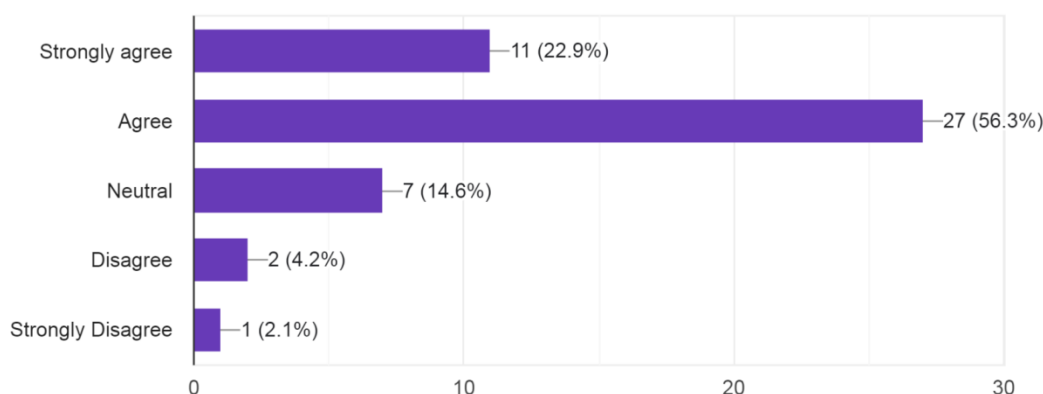

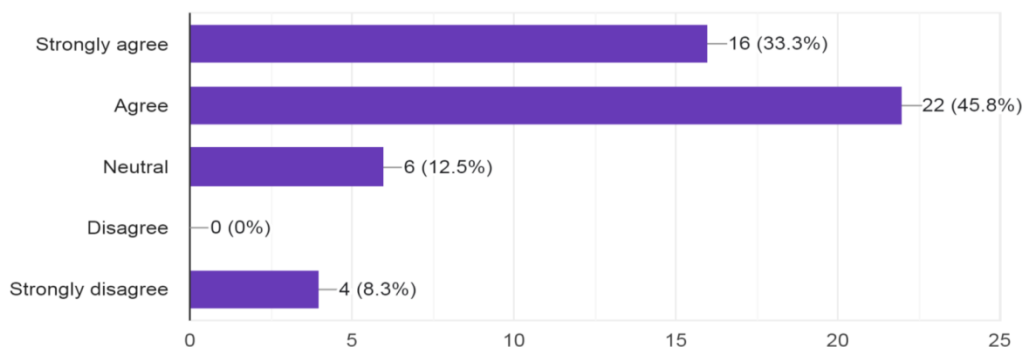

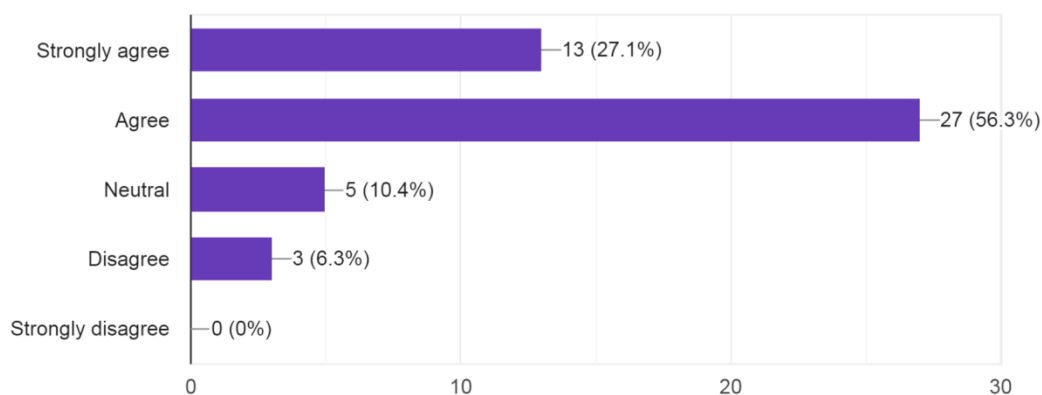


About the infrastructure facilities 33.3% responses are strongly agree, 45.8% are agree, 12.5% are neutral and 8.3% responses are Strongly disagree.

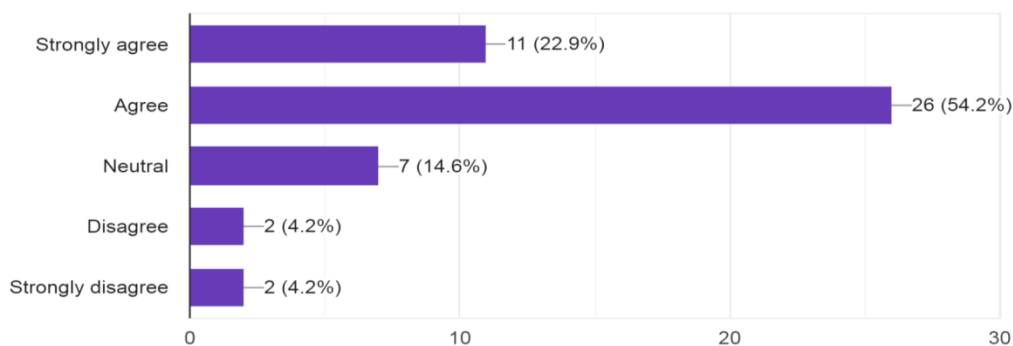

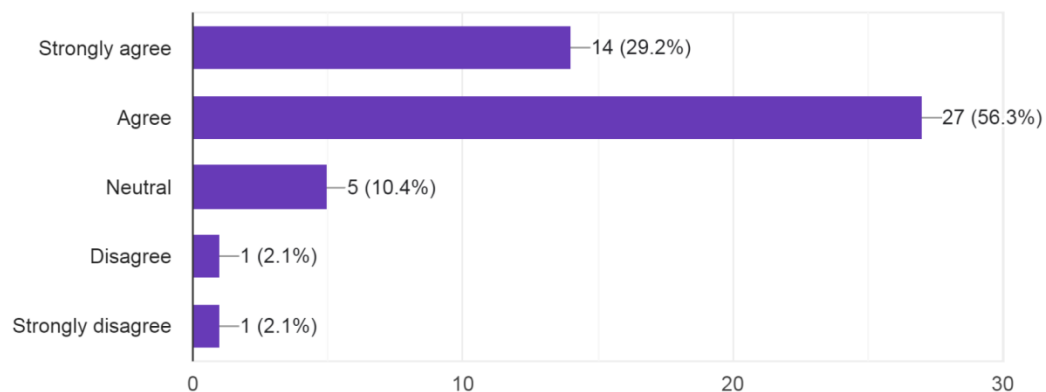

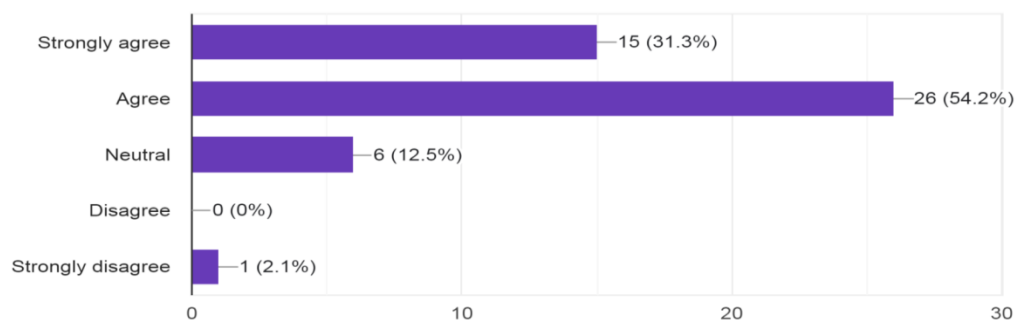

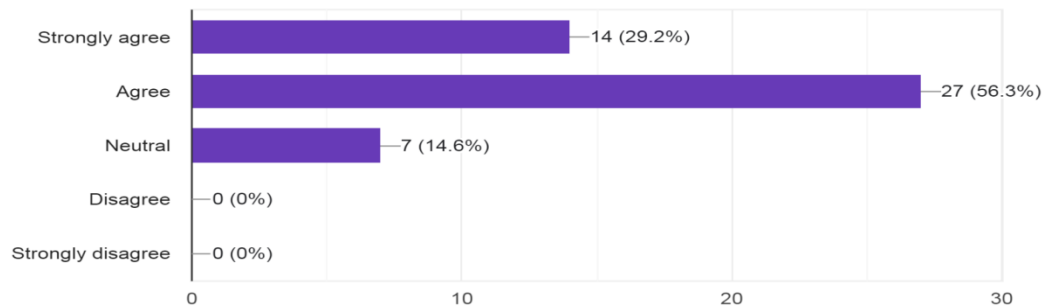

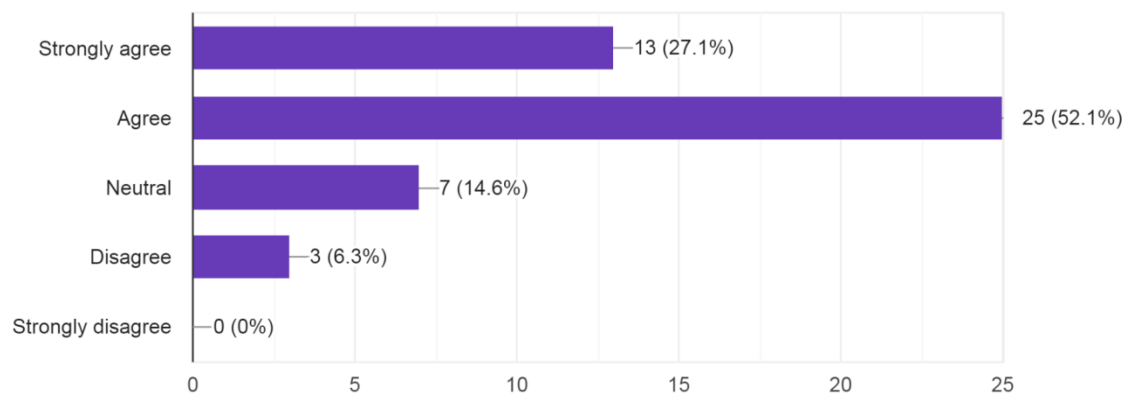

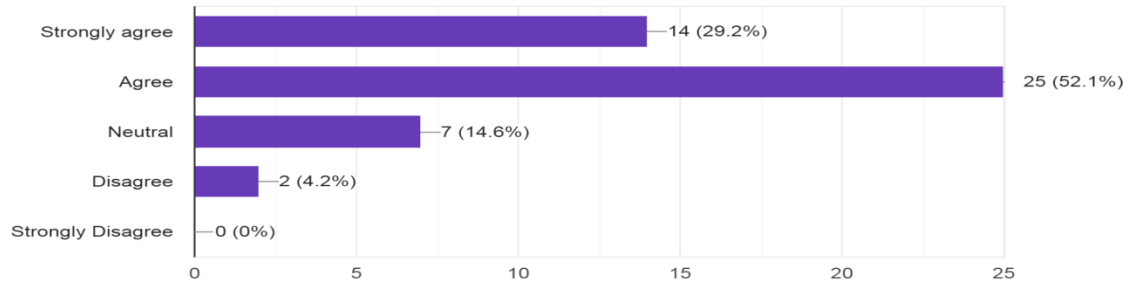


For the question related to environment in the department for teaching and research 27.1% response are strongly agree,52.1% are agree,14.6% are neutral, 6.3% are disagree.

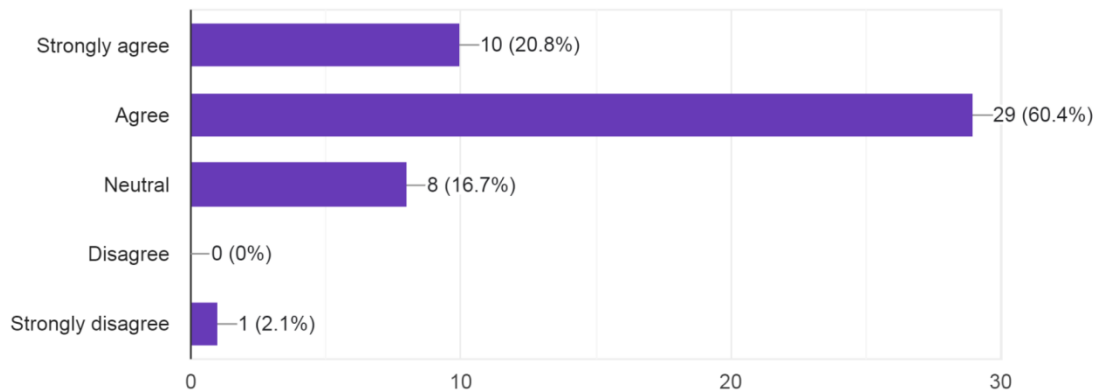

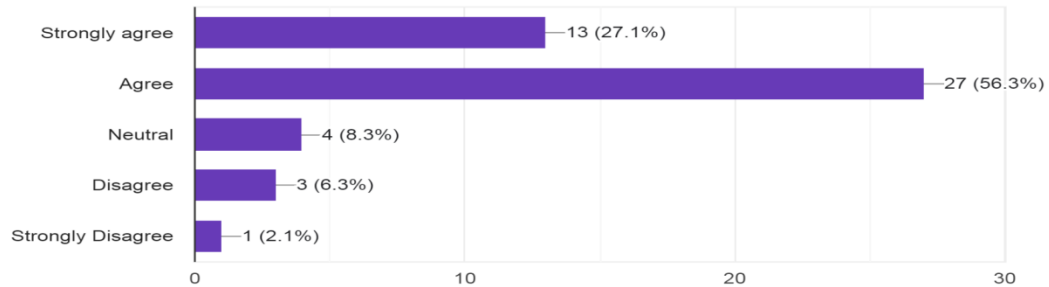


The above graph shows, 20.8% responses are strongly agree, 60.4% are agree 16.7% responses are neutral and 2.1 % responses are strongly disagree.

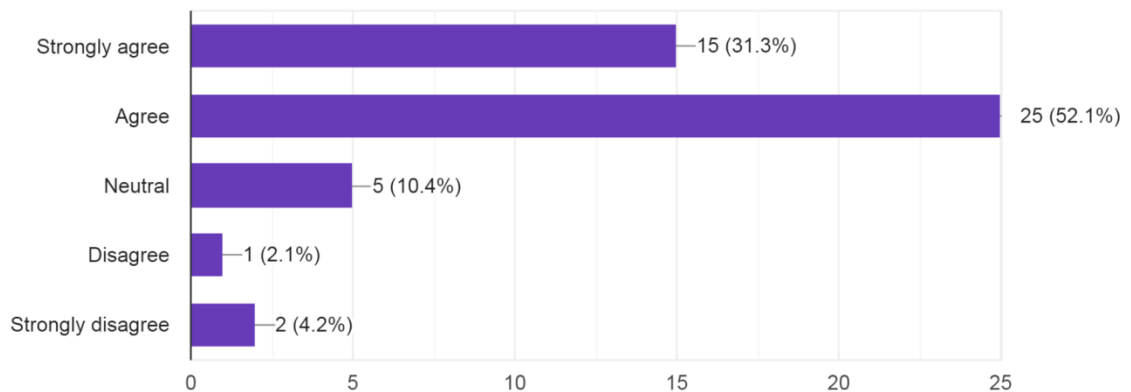

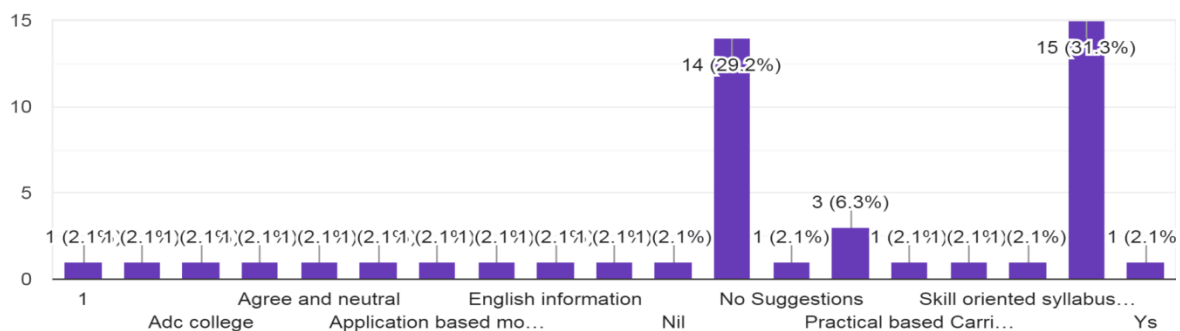

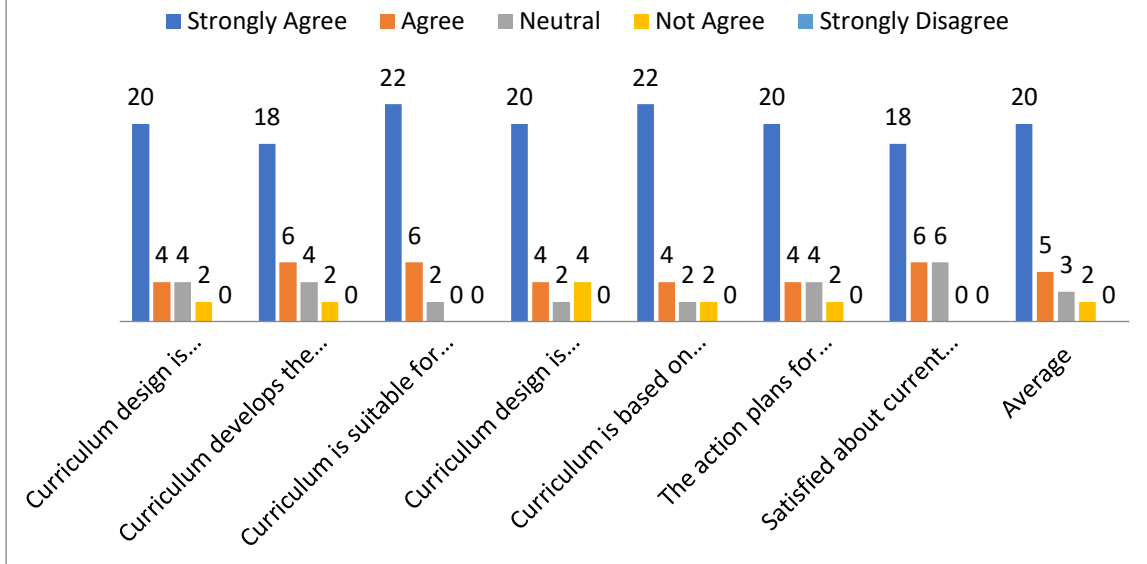
