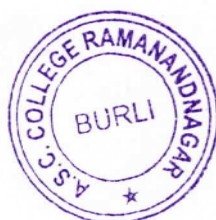

- 5) To discuss on grievances of SC/ST/OBC students, teachers and non-teaching staff.

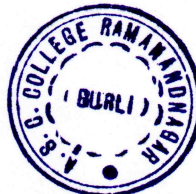

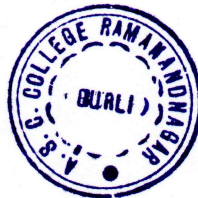

There is no any social, religious, discrimination complaints received from SC/ST/OBC students, teachers and non-teaching staff.

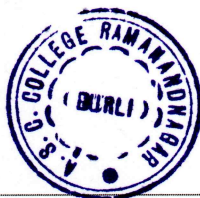
